

The Pyramid Model at RCN

1 Individualized Intervention
3 Supportive Environments
2 Positive Relationships
3 Systems Thinking

In 2013, Executive Director Dr. Lynn Lubecki discovered the Pyramid Model as a solution to challenging behaviors. RCN is known for serving children with challenges, including kids that other centers had refused to serve. Dr. Lubecki began

the implementation of the Pyramid Model to support and equip RCN's teachers, thus giving our children the skills and support they need to succeed.

The Pyramid Model focuses on changing teacher practice and behavior to support the social emotional growth of the children in their care. Mackenzie Albert is RCN's Director of Quality Programming, and she and Dr. Lubecki are Master Cadre Trainers in the Pyramid Model. "This is not just something that we do," Ms. Albert says. "The Pyramid model has become who we are. It is a framework that embodies our mission and how we impact children. We aren't just making sure they are school ready, we're making them life ready."

RCN has committed to training every teacher and investing in our staff. Teachers are more prepared and supported, have a deeper understanding of why children do what they do, and now see how teacher behaviors affect children. Most importantly, kids with challenging behaviors are starting their education with positive school experiences, thwarting future suspension, expulsion, and incarceration.

Ms. Albert and Dr. Lubecki are bringing the Pyramid Model to organizations throughout Greater Rochester. They train teachers and child care providers from schools, child care centers, and libraries. Their vision is to ensure that all local children learn social emotional skills. For their efforts and success in implementing the Pyramid Model, Dr. Lubecki and Ms. Albert were awarded the National Pyramid Model Champions Award in April.

RCN touches the lives of more than **2,000 children** in the Rochester area. RCN provides comprehensive, whole-child, early childhood education services to children through Universal Pre-Kindergarten, Expanded Pre-Kindergarten, private pay and subsidized child care, special education, school age wraparound care, and in-home childcare business support and monitoring.

Special Education

Chase is a happy 4 year old, living life to the fullest with his three cats, two dogs and his parents, Melissa and Jarrod. Chase says "Hi!" to everyone, engages in full-fledged conversations and loves to tell his friends what he did the night before.

Chase was diagnosed with autism at 18 months. He struggled to communicate, at times flipping over chairs in his frustration. He attended a local childcare until Melissa, Jarrod and Chase found Stepping Stones. At last, Chase was in a place that understood him. He made wonderful progress, while Mom and Dad learned how to help their son interact with his world.

Melissa and Jarrod were devastated when Stepping Stones closed abruptly in 2017. In their search for a new center they found RCN. Within a few days Pat Graff, RCN's Director of Special Education, made room in one of integrated settings for Chase. Still, Melissa and Jarrod were terrified. With a child who was so strict about routine, a change could disrupt Chase and his entire family. "But," Melissa says, "We all immediately fell in love with RCN. While we were filling out his paperwork, Chase quietly played with the other kids, went outside with them, and came in to have a snack. It was as if he'd been going to RCN for years!"

Chase started in RCN's Inchworms classroom. Our teachers worked closely with him to understand why he responded in certain ways, and then explaining things in a way that Chase could understand. "Chase is a different kid since he started at RCN". Melissa says. "He regulates his emotions more consistently and can verbalize his wants, needs, frustrations, and accomplishments. Chase's ability to function in a non-structured environment is worlds better than it was a year ago. Everything about him has improved at RCN. More than anything, it gives us hope."

Chase starts Kindergarten this fall in a class with a small number of children. "I don't worry about his ability to fit in, as long as his new teachers give Chase the individualized attention that RCN so effortlessly provided." Melissa also has encouraging words for parents of children with special needs. "At first, hearing the word 'autism' is a hard pill to swallow. Once you've mourned the possibility of having a 'typical' child, you realize how incredible your child can be. You'll find many amazing allies in your journey as you advocate for your child."

"Children with special needs are challenging, but life with them is worth the time and effort. I wouldn't change a thing about Chase. He lives in a whole different world, one that I am honored to be a part of. I can't totally explain how thankful our family is for Ms. Pat, Mr. Mike, Ms. Keyana, and Ms. Katie. I hope that RCN continues to impact children and families the way they have affected us. I hank you so much!"

Family Child Care

On the outside, Luv U 4Ever Learning Academy blends into the neighborhood. You'd never suspect that inside there is a cozy classroom filled with learning and laughter. Ms. Regina Brown (pictured right) is the owner of Luv U 4Ever Learning Academy, an In-Home or Family Child Care (FCC) provider in Henrietta. She and her husband, Clemont, care for up to eight children during the day in addition to a couple after school. Though they are licensed to care for more children, they keep their enrollment at 8 because they want to ensure every child receives the care and attention they deserve.

When Ms. Brown decided to start her own business in 2011, she organized her approach to give children the attention and focus on learning they need. With 16 years of experience as a Head Start Teacher, Ms. Brown combines elements from both the High Scope and Creative Curriculums along with elements she has created. The children differ in age, but during circle time, they support and challenge one another. They have a daily schedule and routine, and the class runs like a well-oiled machine. Luv U 4Ever has the educational feel of a school, but the love and comfort of a home.

Ms. Brown's main goal is for children to have what they need when they leave to go to school, and she knows that earning a child's trust, helping them know they are safe, and being a part of children's development are the most important things to shape happy, confident children. "I love being a part of the children's lives," she says, "I really do love them. It's a special treat running into them years later and listening to them talk about things we did together."

RCN works closely with In-Home and Family Child Care providers to ensure children and families throughout the Rochester area have access to quality care and education, whether in a school, or inhome or family setting. RCN facilitates reimbursement for the nutritious meals FCC Providers serve through the USDA's Child and Adult Care Food Program (CACFP). In addition, RCN offers professional development, technical assistance, and capacity building to FCC Providers through RCN's FCC Satellites of Greater Rochester office. Ms. Brown is part of the Child and Adult Care Food Program administered by RCN. She has taken a variety of classes with RCN and especially likes the in-home trainings.

FCC providers like Ms. Brown play a vital role in caring for and educating the children in our community, with 350 providers operating in Monroe County alone. By working with over 125 providers in Rochester, RCN helps to ensure that FCC providers touch the lives of every child they care for, just like Ms. Brown.



Celebrating Kids, Changing Lives

Four years ago, RCN launched a capital fund drive. Our four-acre property on South Avenue needed a lot of work. The play areas hadn't been improved in years. The original 1954 boiler was inefficient and needed regular repairs. The old doors and windows allowed too much heat to escape in the winter, and kept our rooms too warm on summer days. RCN even experienced occasional flooding in some classrooms after heavy rainstorms.

We set our sights on raising a modest \$250,000. The generosity of Rochester quickly surprised us. We shot past \$250,000 and revised our goal to \$1.2 million. The renovations began in 2015 and have continued since then.

In the 2018-19 school year, we will upgrade our heating/air conditioning systems and begin the complete renovation of our backyard play areas. We envision a natural play scape with a three-season classroom, and paved paths with inviting destinations (think terrain slides and rain gardens) along the way.

RCN welcomes your financial partnership as we move forward. I ogether, we will create a comfortable, efficient center that meets the needs of the 250 children who learn here each day, their teachers, and our programs that impact thousands of children across the region. 


